NEW YORK--(BUSINESS WIRE)--Jun. 18, 2009-- Acadia Realty Trust (NYSE: AKR – “Acadia” or the “Company”), a real estate investment trust (“REIT”) announced today that it will release its Second Quarter 2009 earnings on Wednesday, July 29, 2009 after market close.
